A Military Commission under the provisions of G. O. 100
A G Office series 1863 is hereby convened to meet at (9) o'clock to-morrow, or as soon thereafter as practicable to hear and determine the cause of Chaplain Henry I. Walker 12th Wis V V I and such others as may come before it. The members of the Commission will not be relieved from other military duties except when the Commission is in actual session, will sit without reference to rank, and will assemble from time to time as necessity requires, on the call of the recorder.

The Commission being duly sworn proceeded to the hearing of the case of Lieut. A. McDaniel 78 th Ohio Inf. who it appears received a leave of Absense for 30 days, dated H'd Qrs Dept. and Army of the Tenn, East Point Ga. Sept 18 th 1864. Endorsed availed himself of this leave Oct 22 nd 1864. The Commission find that Lieut. A. McDaniel 78 th Ohio Inf returned to his Command on the 25 th day of March 1865, thus overstaying his leave of Absense 92 days.

It further appears that Lieut. A. McDaniel reported at H'd Qrs. Dept. and Army of the Tenn. on the 17 th day of November 1864 on his way to join his Command and was assigned to duty by virtue of the following Order.

Gen'l Steedman for assignment to duty.

The Commission find that Lt. A. McDaniel 78 th Ohio Inf. remained on duty in said retachment until the 25 th day of March 1865, when he was relieved from duty in said Detachment, and reported to Commanding Officer for duty.
