In accordance with Genl. orders from superior Hd. Qrs. and in order to increase the efficiency and improve the health of the Regt. It is hereby ordered.

- I" That each company commander institutes a school for non-commissioned officers and to instruct them in the general positions of the soldiers, manual of arms, and giving commands.
- II" Squad drill will be instituted under the supervision of the company commanders at least twice each day; at the following hour; from 8 to 9 A.M. and from 4 to 5 P.M. in which the men will be instructed particularly in the "School" of the soldier; such as his position without and with arms; Facings; alignments; manual of arms; and the principals and cadence of command quick; and double quick time; strict attention must be given to the minutial; to this and non-commissioned officers if not prepared, must prepare themselves immediately.
- III" A regimental school for officers will be established, in which commissioned officers will be questioned in regard to the school of the Co. and Battalion and the non-commissioned officers instituted in the school of the soldiers and company.
- IV" Each company commander will inspect the food of his men to see that it is perfectly prepared and of a wholesome character. It is recommended that a great amount of soup and gravy be made use of in frying meat. That it may not be crisped or burned, which renders it indigestible and unwholesome, thereby causing the different forms of diarrhea which are now prevalent with me.
- V" It is strictly enjoined upon company commanders to inspect their company quarters and men's clothing every morning immediately after inspection of arms to see that the sanitary condition of their Co. be good and more especially that greater precautions may be taken to rid the mess of all vermin.

To this end they will see that their clothes are washed and changed at least twice per week; that their bedding is exposed to the sun after and

3rd All officers in command of corps. And of fixed military posts will assume the very highest powers allowed by the law of man and congress. They must maintain the best possible discipline and suppress all disorders. Alarms and dangers within their reach. Citizens who fail to support their government have no right to ask for favor and protection but if they actively assist no in vindicating the National authority all command will assist them and their facilities in every possible way.

Officers need not meddle with matters of trade and commerce whereby law devolve upon the officers of the treasury department but whenever they discover goods "Contraband of war" being conveyed towards the public enemy they will seek all the goods tainted by the transaction and imprison the parties implicated in the matter but care must be taken to make a fullered and report each case.

When a district is ingested by guerillas or held by the enemy, horse mules wagons born forage Ve. are all means of war.

My people do not want their horses. mules. corn Ve. Taken they must organize and suppress all guerrillas or hostiles found in their neighborhood.

- 4th It is represented that officers provost marshal and others in the military service are engaged in business or speculation on their own account and that they charge far for permits. Passes Ve. All this is a breach of honor and laws. Any salaried officer of the military service and may honor his time every thought of his mind to his government and if he takes one end cent of profit beyond his pay he is corrupt and criminal. All officers and soldiers in this Dept. are hereby commanded to engage in no business except their sworn duty to their government.
- 5th Every man should be with his proper Corps. Division Brigade and Regiment unless absent <u>sick</u> or <u>wounded</u> or <u>detached</u> by written order of a competent commander.

Soldiers when so absent must have their descriptive rolls and when not provided with them the presumption is they are improperly abroad.

Mustering officers will see that all absentees not away be the written order of their proper commanders are reported on the master rolls as deserters that they must loose their pay bounty and pension; which a generous government and people have provided for the soldier and officers who do their whole duty. The best hospitals in the world are provided for the sick and wounded but these must be made the receptacles for absentees who suck to escape the necessary exposures and dangers of a soldiers life. However it is possible either must be employed as nurses, evoke, attendants, stewards Ve. to hospitals in order that the enlisted man maybe – where they belong – with the Regts. Medical inspectors will attend to his wounds.

The General commanding that announces that he expects the wounded and sick to have every care possible but this [unintelligible] be abused to the injury of the only useful post or are away [unintelligible] soldiers in the field.

In time of war and rebellion districts of country occupied by such troops are subject to the laws of war. The inhabitants be they friendly or unfriendly must submit to the controlling power. If any person in our insurgent district correspond or trade with an enemy outside he or she becomes a spy - and all the inhabitants' moreover must abstain from hostile or unfriendly acts, but must aid and assist the power that protects them and afford them trade and commerce. The people who occupy this department had better make a note of this and conduct themselves accordingly.

Vicksburg. Miss. January 1864.

The committee appointed for the purpose of passing judgment on the regiments comprising the 2nd Brig. 3rd Div. 17th Army Corps as to which excelled in discipline solder by bearing of the men, manual of arms, and cleanliness of ranks consider the 17th Ohio Infantry Col. the most meritorious.

They do not wish in doing so to reflect on the brave soldiers of the 32nd, 20th and 68th Ohio Regts. who had but little opportunity for drilling Lieut. Col Wiles deserves great – credit – for overcoming difficulties in drill his regiment which is worthy of the highest commendation.

In the manual of arms the 78th Ohio should be an example to the other regiments of the Brigade who certainly have had the same opportunities for protecting themselves in the school of the Soldiers of the 78th.
